

**Personal Information Protection and Electronic Documents Act
Policy of Harvest Bible Chapel Branford
January 2018**

1. Accountability

- 1.1 The executive pastor is hereby appointed as the personal information compliance officer (the “officer”).
- 1.2 All persons, whether employees, volunteers, or board/team members who collect, process, or use personal information shall be accountable for such information to the officer.
- 1.3 This policy shall be made available upon request.
- 1.4 Any personal information transferred to a third party is subject to this policy. The officer shall use contractual or other appropriate means to protect personal information at a level comparable to this policy while a third party has this information.
- 1.5 Personal information to be collected is done so only using applications and forms approved by the privacy officer. All methods of retention of information are according to the officer’s instructions.
- 1.6 Any person who believes the church uses personal information collected, make contact the officer to register a complaint or to make any related inquiry.
- 1.7 Upon receiving a complaint from any person regarding the collection, retention, or use of personal information, the officer shall promptly investigate the complaint and notified the person who complained about his findings and corrective action taken, if any
- 1.8 Upon receiving the response from the officer, the person who filed the complaint may, if he/ she is not satisfied, appeal to the churches board of elders to review and determine the disposition of the complaint at issue.
- 1.9 The determination of the board of elders shall be final and the officer shall abide by and implement any of its recommendations.
- 1.10 The officer shall communicate and explain this policy and give training regarding it to all employees and volunteers who might be in the position to collect, retain, or use personal information.
- 1.11 The officer shall prepare and disseminate information to the public which explains the churches protection of personal information policies and procedures.

2. Identifying Purposes

- 2.1 The officer shall document the purpose for which personal information is collected to comply with the openness of the individual being able to access their own personal information.
- 2.2 The officer shall ensure that only information needed to fulfil purposes for which the information is to be collected is asked for on the forms/applications Harvest Bible Chapel uses. To comply with the limited collection principal below.
- 2.3 The officer shall ensure that the purpose is implied or specified at or before the time of collecting the personal information from an individual.

2.4 The officer showing sure that the information collected Will not be used for any other purpose before obtaining the individual's approval, and Unless the new purpose is required by law.

2.5 The officer shall ensure that a person collecting personal information will be able to explain to the individual why this is being done.

2.6 The officer shall ensure that limited collection, Limited use, disclosure and retention principles are respected in identifying wide personal information is to be collected.

3. Consent

3.1 The officer shall ensure that the individual from whom personal information is collected consents to this end to it being used and disclosed, unless obtaining the consent would be inappropriate. Sometimes personal information, used, or disclosed without the individual's knowledge and consent. For example, legal, medical, or security reasons might make seeking consent impossible or impractical. When information is being collected to detect and prevent fraud, seeking the individual's consent my defeat collecting information's purpose. Seeking consent might be impossible or inappropriate when the individual is a minor, seriously ill, or mentally incapacitated.

3.2 The officer shall ensure that the individual can reasonably understand why and how the information will be used when the consent is given.

3.3 The officer showing sure that where implied consent cannot be assumed, express consent is obtained wherever possible and appropriate. Such an implied consent should not be assumed if the church would pass on the personal information to a para-church organization that is not an integral part of the church.

3.4 iIn obtaining express consent, the officer shall ensure that the individual's reasonable expectations are respected.

3.5 The officer shall ensure that the express consent obtained from an individual is clear and in an appropriately verifiable form whether it be paper or electronic.

3.6 The officer shall ensure that the individual may withdraw consent at any time, subject to legal or contractual restrictions and reasonable notice. The individual shall promptly be informed of the withdrawal's implications.

4. Limiting Collection

4.1 The officer shall ensure the personal information will not be collected indiscriminately. Both the amount and type of information collected Shelby limited to that which is necessary to fulfil the purposes identified.

4.2 The officer shall ensure that information is collected only by fair and lawful means without misleading or deceiving individuals as to the reason period

4.3 The officer shall ensure that the identifying purposes and consent principles are followed and identifying why personal information is to be collected.

5. Limiting use, disclosure, and retention

5.1 The officer shall ensure that personal information shall not be used or disclosed for purposes other than those for which it was collected, except with the consent of

the individual or as required by law, and any use of personal information shall be properly documented.

5.2 The officer shall ensure that all personal information is destroyed, erased, or made anonymous as soon as the purpose for which it was collected is no longer relevant, or as permitted by law. Except as required to be retained by law, all personal information shall be deleted, erased or made an anonymous no later than seven years after the purpose for which it was collected has been completed.

5.3 The officer shall ensure that all use, disclosure, and retention decisions are made in light of the consent principle (individual giving consent to use information), the identifying purposes principle (that purposes of collection are made known), and the individual access principle (that individual is allowed access).

6. Accuracy

6.1 The officer shall ensure that the information is sufficiently accurate, complete, and up-to-date to minimize the possibility that inappropriate information might be used to make a decision about an individual.

6.2 The officer shall ensure that the church does not routinely update personal information, unless it is necessary to fulfil the purposes for which the information was collected.

6.3 The officer shall ensure that personal information used on an ongoing basis, including information that is disclosed to third parties, should generally be accurate and up-to-date.

7. Safeguards

The officer shall ensure that the church has security safeguards to protect personal information against loss or theft, as well as on authorized access, disclosure, copying, use, or modification. He/she shall do this regardless of the format in which the church holds the information.

7.2 Depending on the information's sensitivity, the officer may permit reasonable discretion regarding the information that has been collected: the amount, distribution, format, and method of storage. A higher level of protection shall safeguard more sensitive information according to the consent principles considerations.

7.3 The officer shall ensure that the protection methods include

(a) Physical measures, for example, locked filing cabinets and restricted access to offices

(b) Organizational measures, for example, security clearance and limiting access to need to know basis; and

(c) Technological measures, for example the use of passwords and encryption.

7.4 The officer shall ensure that all employees and volunteers know the importance of keeping personal information confidential.

7.5 The officer shall ensure that care is taken when personal information is disposed of or destroyed to prevent unauthorized parties from gaining access to it.

8. Openness

8.1 The officer shall ensure that the church is open about its policies and procedures

regarding the management of personal information. The policies and information about the related practices shall be available without unreasonable effort in a form generally understandable.

8.2 The officer shall ensure that the information available shall include

- (a) The name or title and address of the officer who is accountable for the churches policies and practices and to whom complaints or inquiries can be forwarded;
- (b) The means of gaining access too personal information held by the church;
- (c) A description of the type of personal information held by the church, including a general account of its use;
- (d) A copy of any brochures or other information that explain the churches policies, standards, or codes; and
- (e) What personal information is made available two related organizations (e.g., organizations that are affiliated).

8.3 The information that must be provided according to 8.2 is available either in a brochure at the locations the church operates, online, or through the mail.

9. Individual Access

9.1 The officer shall ensure that upon request the church shall inform an individual whether the church holds personal information about him/her. If possible, the information source shall also be given. The church shall allow the individual access to disinformation. The church may, however, choose to make sensitive medical information about its employees or volunteers available through a medical practitioner. The church shall also account for the use that has been made or is being made of this information and give an account as to the third parties to whom it has been disclosed. (Note, if the officer believes for valid reasons that access to personal information should be denied, before making such a decision.)

9.2 A person requesting his/her personal information maybe required by the officer to give sufficient information to permit the church to provide an account of the existence, use, and disclosure of personal information. Information shall be used only for the purpose for which it was obtained.

9.3 If the church has supplied personal information how About an individual to third parties, the officer shall ensure that an attempt is made to be as specific as possible. When to which it has actually disclose information about an individual is impossible, the church shall provide a list of organizations to which it may have disclosed the information about the individual.

9.4 The officer shall ensure that the church responds to an individual's request within a reasonable time and that minimal or no cost to the individual. The requested information shall be made available in a generally understandable form. For example, a church shell explaining abbreviations or codes it uses to record information.

9.5 The officer shall ensure that when an individual successfully demonstrates the inaccuracy or incompleteness of personal information, the church shall amend the information as required. Depending on the information challenged, amendment involves the correction, deletion, or addition of information. When appropriate, the amended information shall be transmitted to third parties having access to the information in question.

9.6 The officer shall ensure that when the challenge is not resolved to the individual satisfaction, the church to record the unresolved challenges substance. When appropriate, the unresolved challenges existence shall be transmitted to third parties having access to the information in question.

10. Challenging Compliance

10.1 the officer is authorized to address a challenge concerning compliance with the above principles.

10.2 the officer shall develop procedures to receive and respond to complaints or inquiries how About the policies and practices regarding the handling of personal information. The compliance procedures shall be easily accessible and simple to use.

10.3 the officer shall inform individuals inquiring about lodging complaints that relevant complaint procedures exist.

10.4 The officer shall investigate all complaints. If a complaint is found to be justified, the officer shall take appropriate measures, including, if necessary, amending the policies and practices.
